****NEW** Budget Letter Sent to House Reps Urging Balanced Approach**

On April 27, Meg Flack, LWVO President, sent a letter to members of the Ohio House of Representatives urging a balanced approach to the state budget. It stated, “We believe Ohio can both achieve the goal of an improved economic environment in which Ohioans can find employment and earn a living wage – and the goal of ensuring that Ohio’s children and most vulnerable citizens are protected.” The letter outlines where the proposed budget threatens to undermine the supports necessary for an educated workforce and business-friendly tax environment and then goes on to suggest areas of tax expenditures that deserve serious consideration.

LWVO is preparing a press release of the same nature that will be sent out as the budget bill moves from the House to the Senate.

****NEW** Election Bills Moving Fast**

Legislation has been introduced in the House and Senate to address election administration reform. LWVO is monitoring the bills and will keep you posted on their progress. The Secretary of State is testifying tomorrow on [SB 148](#) while the House is working on a substitute bill for [HB 194](#).

LWVO election-law lobbyist Peg Rosenfield testified March 22 before the House State Government and Elections Committee in opposition to HB 159. If enacted, the legislation would require voters to show government-issued photo-ID at the polls. This could disenfranchise legitimate voters and discourage them from exercising their vital right to vote, and it would cost a lot of money that Ohio does not have -- all to solve a problem that does not exist. [Click here](#) to read the LWVO testimony. [HB 159](#) passed the House but is thus far stalled in the Senate.

****NEW** Elect Your Sticker Campaign Begins May 8**

There’s nothing like the satisfaction you get from casting your ballot to support your favorite candidate or cause on Election Day. For many, the sticker you’re given to wear, announcing the fact that you voted, is a great source of pride.

Secretary of State Husted is asking Ohioans to get involved with this tradition by helping decide the look and message that will be used for Ohio’s next “I Voted Today” sticker. The Secretary of State’s office has developed six new designs and is running the “Elect Your Sticker Campaign” from May 9 through August 8.

****REMINDER** Deadline to Transfer Local League Education Funds: June 30, 2011**

We are in the fourth quarter of our fiscal year and following up on earlier notes; the LWV-Ohio Education Fund will discontinue administering local League education funds (LLEFs) at the end of this fiscal year—June 30, 2011—rather than start charging fees of participating Leagues.

To continue to ensure the local Leagues' ability to easily maintain their education funds, the board has investigated and shared a number of options for transferring administration of your League's education fund to another entity with the presidents and treasurers of the local Leagues. **The LLEFs currently administered by the state Education Fund must be transferred from the LWV-Ohio Education Fund before the June 30, 2011, deadline.**
